The Trade National Single Window (TNSW) System in Sri Lanka is an innovative initiative aimed at simplifying and streamlining the process of international trade by providing a centralized digital platform by integrating various government agencies, customs, and stakeholders involved in import and export procedures, allowing businesses to submit all necessary documents and comply with regulations through a single interface. The TNSW system is designed to reduce paperwork, minimize delays, and enhance the efficiency of cross-border trade. It also promotes transparency, reduces costs for businesses, and helps Sri Lanka align with global best practices in trade facilitation.

The Scope and objective of the assignment

The main objective of conducting the need assessment is to offer practical guidelines for examining the current status of GAs for National Single Window development and providing suggestions for future improvements that align with global best practices and recommendations. The Assignment is to be conducted to cover Eighteen (18) Government Agencies.

Accordingly, The Project Consultants Procurement Committee on behalf of the Trade National Single Window System Project invites eligible consultancy firms to extend their Expression of Interest (EOI) for the above assignment.

The purpose of this EOI is to enable the Trade National Single Window Project to identify the potential consultancy firm, who will subsequently be invited to submit their proposal for the abovementioned consultancy. Interested consultants should demonstrate that they have required qualifications, resources and experience to perform the above Assignment. The submitted EOIs will be evaluated based on the following aspects and only short-listed applicants will be notified and invited for a more detailed proposal submission.

- 1. Business registration.
- 2. Relevant experience and qualifications of the consulting firm.
- 3. Experience of the firm in dealing with similar assignments.
- 4. Qualifications and experience of the key personal allocate for the assignment

A consultancy firm will be selected in accordance with the procedures set out in the Government Procurement Guidelines of Selection & Employment of Consultants. The method for the selection is based on the Quality and Cost Based Selection (QCBS). Duration of the assignment is 03 months.
